# EDUCATIONAL & OTHER QUALIFICATIONS: Essential:

- (i) Post Graduate Degree/DNB/Post Graduate Diploma holders in any specialty (above mentioned subject/discipline) recognized by NMC (erstwhile MCI) for not less than 2(two) year. Holders of Permanent Registration Certificate of any State Medical Council/NMC (erstwhile MCI).
- (ii) Permanent Resident Certificate of Tripura (PRTC) would be required while applying for jobs by direct recruitment as per Notification of GA (P&T) No.F.23(8)-GA(P&T)/2023 dated 07/07/23.

**DESIRABLE**: Knowledge in Bengali or Kok-borok as per Memorandum of GA (P&T) No.F.20(1)-GA(P&T)/2018 dated 02/01/2021.

<u>Age:</u> - Below 40 years as on **04.02.2025**. (This will be strictly adhered to save in cases of exceptionally qualified candidates where the age limit be relaxed by not more than three years) Relaxable by 5 (five) years in case of SC/ST/PH/PWD candidates and Government servants candidates However, the SC/ST/Govt. Servant will not get the further relaxation of 5(five) years over and above relaxation of 5(five) years which they are already entitled to get as SC/ST candidates.

The last date of submission of online application is 04.02.2025 (up to 5.30 PM). The application (s) received after the closing date will not be entertained.

\* Selection procedure; the selection process and marks distribution for Specialist Cadre as follows: API-85 Marks and Interview = 15 marks, Total=100 marks as per "Annexure-A"

#### **Selection Process:-**

- (a) As per service rules the recruitment process will comprise of 02 (two) steps: viz -
  - (i) Screening by API Score: 85 marks of API Score.
  - (ii) Interview/ Viva: 15 marks.
- (b) For detailed selection process please refer to Health & Family Welfare Department's Notification No.F.3(457)-HFW/2019 dated 26.10.2022. Short-listing of candidates for Interview as per API Score for Specialist Cadre as per "Annexure-A".
- (c) 15 Marks allotted for Interview/ Personality Test: Assessment of Domain Knowledge in professional field, Technical knowledge, Practical experience, Interpersonal skill, Presence of Mind & Attitude, IQ etc.
- (d) Candidates will be called for the Interview/Personality Test in category wise on the basis of API Score in the following ratio:

Number of vacancies	Number of candidates to be called for Personality Test (Category wise)
l (one)	5 (five) candidates
2 (two)	8 (eight) candidates
3 (three) and above	3 (three) times the number of vacancies

Candidate(s) scoring marks equal to that of the last candidate so selected for the Personality Test will also be called for Personality Test.

- (e) The final selection will be made in order of merit on the basis of the marks obtained by a candidate (API Score) and by adding the marks obtained in the Interview process (out of 15 marks). If a candidate remains absent in the interview process, his/her candidature will not be considered for final merit list.
- (f) In the list of recommendation, merit position of candidates securing equal marks will be finalized as per their seniority of age. The same procedure is to be followed for preparing waiting List, if there be any.

Further provided that, in the list of recommendation, merit position of candidates securing equal marks in aggregate and also of the same age will be decided on the basis of percentage of marks obtained in the minimum educational qualification prescribed in Recruitment Rules/ Service Rules.

(g) Ranks of the candidates are not prepared for the candidates beyond the recommendation list & wait list (if there be any).

## Jther Important information:-

## 1. Online Application Portal:

- (a) Candidates will have to submit application through Online Application Portal only. The Commission will not entertain any hard copy application. Before submission of online application, read carefully the instruction to candidates.
- (b) Online Application Portal will be available on Commission's website from 10.01.2025 to 04.02.2025 (up to 5.30 PM). Before applying for the post, an applicant shall register his/her bio- data particulars through One Time Profile Registration (OTPR) on the Commission's Website viz. tpsc.tripura.gov.in. Once applicant registers his/her particulars, a User ID is generated and sent to his/her registered mobile number / email ID. Applicants need to apply for the post using the OTPR User ID through the Commission's website.
- (c) Applicants should avoid submitting multiple applications. However, if due to any unavoidable circumstances, any applicant submits multiple applications then he/she must ensure that the application with latest Receipt Number is complete in all respect.
- (d) In case of multiple applications, the application with latest Receipt Number shall only be entertained by the Commission and fee paid against one Receive Number shall not be adjusted against any other Receipt Number.
- 2. (a) Candidates are required to submit self attested copy of certificates in support of their claims regarding Age, Educational Qualifications Madhyamik on words (all marksheet and certificates) All attempt Certificate of MBBS, PG (MD/MS/Diploma)/DNB/Post Graduate Diploma Holders, Publication, Registration Certificate from the appropriate authority, Permanent Resident Certificate, Scheduled Castes/Scheduled Tribes, Experience Certificates, API score (as per Annexure-A) and others, if mentioned in the application form in the receipt section of the TPSC or by post address to the Secretary, TPSC, Agartala, PIN: 799001. Submission of such documents will be allowed up to 17.02.2025 along with printed copy of Online Application failing which candidature will be treated as cancelled. The Commission will not entertain any application thereafter.
- b) Applicants must be in possession of the prescribed minimum qualification(s) and others for the post on the closing date for submission of application as mentioned in the advertisement. Their admission at all the stages will be purely provisional, subject to their satisfying the prescribed eligibility condition. Mere issue of admission certificate to the candidate will not imply that his/her candidature has been finally cleared by the Commission.
- (c) On scrutiny of documents, if a candidate is found ineligible as per terms & condition of the Advertisement (including prescribed Recruitment fees) his /her candidature will be rejected. If the application is not routed through proper channel, at the day of interview candidates will have to submit 'no objection' certificate failing which his/ her candidature will not be considered for preparation of final merit list. In that no-objection certificate, it is to be clearly mentioned that your employer has 'No-objection' if you are considered for recruitment to the post for which you have applied for.

#### 3. Rate of Recruitment Fees:

(a) Group-A Posts: - Rs.400/- (rupees four hundred) only for General Candidates and Rs. 350/- (rupees three hundred and fifty) only for ST/SC/BPL card holders/Physically Handicapped Candidates.

- (b) If a candidate submits incomplete application in respect of terms & condition of the Advertisement and without requisite recruitment fee, his/her candidature will be rejected.
- (c) Recruitment fees so deposited, is non refundable.
- **4.** Decision of the Commission as to the eligibility or otherwise of a candidate at any stage of the selection process shall be final.
- 5. Assessment and evaluation of necessary documents done by the Commission shall be final and shall not be open to scrutiny by any external authority.
- 6. Candidates are instructed to visit the Commission's website for information regarding steps of recruitment process time to time.
- 7. Candidates are at liberty to make correction(s) in any field(s) of the 'Online Application Form' for the respective advertisement after closing day of submission of online application window of the said advertisement. The window for making correction(s) only will remain open for 7 (seven) days from the closing day of submission of 'Online Application Form'.

After completion of such process the Commission will not entertain any application/representation for making correction(s) in any field(s) of the 'Online Application Form'.

- 8. Mobile Phone/Electronic Gadgets etc. are banned in the Campus of the Examination Premises /Interview Premises. Any Phone/ Electronic Gadget found in possession of any candidate in the Examination Premises /Interview Premises shall be confiscated forthwith and he/she may be debarred from appearing at the Examination /interview and also for the Examination(s)/Interview to be conducted by the Commission in future Violation of such instruction will be dealt as per Law.
- 9. Entry in the Examination hall/ Interview Premises with Jacket, Coat, Pull over & this type of garments will not be allowed.

- II. 2nd Professional Examination 06marks (Passed in First attempt)
- III. 3rd Professional Examination 14 marks (Passed in First attempt)
- IV. 4th Professional Examination 16 marks (Passed in First attempt)
- V. Full marks will be awarded who passed all professional exams in 1<sup>st</sup> (first) attempt
- 2(two) marks will be deducted from total marks for each additional attempt to pass the professional examination.
- VII. \*5 or more additional attempt to pass the professional examination will invite zero (0) marking the obtained marks of a candidate from the concerned professional exam (From total marks of 10).

## 2) PG (MD/MS/Diploma) Degree: Total Score-35 marks

- Full marks will be awarded who passed his/her Post Graduate examination (MD/MS/Diploma/DNB) In 1" (first) attempt (Total marks 35).
- 5(five) marks will be deducted for each additional attempt (more than one) to pass the Post Graduate professional examination (From total marks of 35).

### 3) Publications: Total Score- 10 marks

- I. Single Research publication/case report 5 marks
- II. 2 or more Research publications/ case report- total 10 marks
- III. Publication must comprise with the latest NMC/MCI approved indexed Journal.
- No marks will be added for Non Index Journal or publication not comprising with latest NMC/MCI guideline for publication of Journal.
- Research paper/Case Report must be published during PG Study period & post PG period.
- VI. Candidate must be first, second or Correspondence Author of the publications, otherwise the marks of publications will not be added.

Subject:- Recruitment to the posts of Junior Medical Officer / General Duty Medical Officer in Grade IV of THS, Group-A Gazetted under the Health & Family Welfare Department, Govt. of Tripura.

Sir,

In reference to your letter No. F.11(26-33)-Rectt/TPSC/2021/568 dated  $20^{th}$  August, 2021 I am to inform you the followings:

 The National Medical Commission of India (MCI) vide Notification dated 25th March, 2009 has restricted the eligibility criteria for physically handicapped candidates for their admission to the MBBS Course.

The eligibility laid down by the NMC reads as follows:-

3% seats of the annual sanctioned intake capacity shall be filled up by candidates with locomotors disability of lower limbs between 50% to 70%,

Provided that in case any seat in this 3% quota remains unfilled on account of unavailability of candidates with locomotor disability of lower limbs between 50% to 70% then any such unfilled seatin this 3% quota shall be filled up by persons with locomotor disability of lower limbs between 40% to 50% before they are included in the annual sanctioned seats for General Category candidate.

2. As per Notification No.23(38)-GA(P&T)/2019, dated 24th January, 2020(Copy enclosed) issued by the GA(P&T) Department, Govt. of Tripura regarding Identification of post to be reserved for person with disabilities in services under Government of Tripura the Medical Officer (under Tripura Health Services) is not identified (ANNEXURE-I). Hence the reservation for physically challenged person has not been provided.

As suggested by the Tripura Public Service Commission the process for review of the recruitment process will be done in due course.
